Being an exotic-ish looking female who was predominantly educated abroad and who looked like she coloured outside the lines, these were often encountered whilst working as a senior lawyer in London. When explaining the importance of networking with female colleagues to increase my client reach, an ex-boss once told me “Be yourself...but not too much of yourself – you don’t want to scare them. Just talk to them about shoes. Girls like talking about shoes, right?”. He said this with good intentions, which gives a sense of the prevailing environment at the time. But what I really wanted to talk about was how gadgets worked, the intricacies of human decision-making, the flavour profiles of complex cocktails, and rock music. Throughout my law studies and career, I subconsciously rallied against the strict expectations and restrictions of the ‘typical’ legal mindset and career path. Over the last 20 years of my career, I have coloured outside the lines and pushed boundaries despite pushbacks. I am now one of the few recognised legal specialists in construction technology.</p>

<p>Provide a brief biography of the nominated individual/organisation</p>	<p>May is a senior construction and insurance lawyer with over 19 years’ experience. She has worked for various international organisations and insurers within the design and construction industry on legal issues as well as advising on risk and implementation of digitisation and technology. May has significant expertise in all areas of construction law, both contentious and non-contentious, as well as construction insurance. She leads the global legal team at Buro Happold, provides legal support on giga projects, as well as leading the risk management of digital and construction technology. May was admitted as a qualified solicitor of England &amp; Wales in February 2004, having been called as a barrister in October 2001. In January 2015, she graduated from King’s College London, gaining a MSc distinction in Construction Law &amp; Dispute Resolution. During her time at King’s College, May was recognised with seven academic awards, including best overall student and best exam script in the arbitration exam. The digital aspect of May’s role includes active involvement in working internally and with clients and collaborators to develop new policies, systems, documents and procedures on construction technology, information management and BIM, as well managing the risk of implementing new digital-related technologies and services. May has a passion for innovation in</p>

the industry and has provided pragmatic advice and thoughts on the legal impact of construction technology to clients and at events worldwide for some years. She is recognised as a leading legal specialist in digital and construction technology, including Building Information Modelling (BIM). May was one of the first UK lawyers to start investigating the legal and contractual implications of BIM, beginning her specialism in 2011. Her 2014 UK Society of Construction Law paper on this issue is still cited worldwide. May also pioneered the drafting of the JCT Practice Note on BIM, the UK legal and contractual guidance relating to the BIM international standard, ISO 19650 and the ISO 19650-compliant BIM Information Protocol. May has authored and co-authored various documents in this field, including legal guidance on the ISO 19650 Information Management international standard, an ISO 19650-compliant Information Protocol, a JCT Practice Note on BIM and an upcoming book chapter analysing Construction 4.0. She is one of the co-authors of the Centre for Digital Built Britain's Digital Twins Roadmap and their recently released Digital Twins Toolkit Report. She is a UK BIM Alliance Ambassador, co-founder and chair of BIM4Legal (a forum for lawyers and industry to increase knowledge on legal issues of BIM) and a member of various other industry groups seeking to support the industry in progressing and implementing digital technology. In 2020, May was recognised as the 'Best Woman in Construction Law' at the European Women In Construction and Engineering Awards (WICE) in honour of her work in the industry. She was named as one of the Construction Idols by London Build 2022, and won the Compliance Innovator award at the highly regarded Lexology European Counsel Awards 2023.
